THE CITIZENS ECONOMIC EMPOWERMENT (TRANSPORTATION OF HEAVY AND BULK **COMMODITIES BY ROAD) (RESERVATION) REGULATIONS, 2021**



Introduction

In a widely circulated Zambian national newspaper the "Daily Mail" dated 4 May 2021, it was reported that local transporters have been granted preference with respect to transportation of at least fifty percent (50%) of heavy and bulk cargo either imported or generated within the country of Zambia. This is following the action by the President of the Republic of Zambia, His Excellency Dr. Edgar Chagwa Lungu, signing the Citizens Economic Empowerment (Transportation of Heavy and Bulk Commodities by Road) (Reservation) Regulations, 2021 (the "Reservation Regulations") on 30 April 2021 pursuant to Local road transporter means section 21 of the Citizens Economic Empowerment Act No. 9 of 2006

To the best of our knowledge, the Reservation Regulations are vet to come into force as they have not been published in the Gazette.

Below is a summary of provisions in the Reservation Regulations.

Application of Reservation Regulations

The Reservation Regulations apply to (i) a producer, a manufacturer or user of a raw material of a heavy and bulky commodity as set out in the schedule to the regulations; (ii) an oil supplier; (iii) a logistic company; (iv) a clearing and

Domestic Transportation

Preference is given only to a local road transporter with respect to Citizen owned company means the transportation of commodity within Zambia. It is a requirement that at least *Targeted citizen* means a citizen fifty percent (50%) of commodity who is or has been marginalized being imported into Zambia is Fertilizer, Petroleum and Maize.

Other Issues to Note

In ensuring compliance, the Reservation Regulations have empowered authorised officers namely police officers, an officer of customs, an immigration officer, an officer from the Drug Enforcement Commission, an officer from the Anti-Corruption Commission, an officer from the Road Transport and Safety Agency, or any person appointed as an authorised officer,
