## LEGAL ALERT

### AGRICULTURAL INSTITUTE OF ZAMBIA ACT



#### Introduction

On 27 June 2023, the Minister of Agriculture, Mr. Reuben Mutolo Phiri, duly issued the Agricultural Institute of Zambia Act (Commencement) Order, S.I. No 19 of 2023, which brought into effect the Agricultural Institute of Zambia Act No.2 of 2017 (the **"Act")**.

We set out below some notable provisions in the Act.

#### **Salient Provisions**

The Act establishes the Agricultural Institute of Zambia (the "**Institute**"), a body corporate whose many functions include:

- Registering agricultural professionals and regulating their professional conduct.
- Promoting the agricultural profession in Zambia.
- Investigating allegations of professional misconduct and imposing such sanctions as may be necessary.
- Advising the Government on matters relating to the agricultural profession.

It is an offence under the Act to practice as an agricultural professionalwithoutregisteringas such. A person who contravenes the foregoing commits an offence and is liable, upon conviction, to a fine not exceeding ZMW 210,000 (approximately USD 10,769.23) or to imprisonment for a period not exceeding seven years, or to both. The Act defines agricultural professional an as "a scientist, technician, or craftsperson in the science of agriculture, but excludes a veterinary professional or paraveterinary professional". The Agricultural Institute of Zambia Act (General) Regulations S.I. No 54 of 2018 (the "General **Regulations**") recognizes four classes of agricultural professionals to register. namely; agricultural professional scientist, agricultural professional technician, agricultural crafts technician, and honorary and life members.

In addition, an agricultural professional is equally required to hold a practicing certificate issued by the Institute. It is an offence for a person to practice as an agricultural professional without a validly issued practicing certificate. A person who contravenes the foregoing commits an offence and is liable, upon conviction, to a fine not exceeding ZMW 210,000 (approximately **USD 10,769.23**) or to imprisonment for a period not exceeding seven years, or to both.

Worth noting as well is the prohibition under the Act from holding out as an agricultural professional unless one is duly registered. The Act prohibits the following unless one is duly registered:

- Practicing as, being employed as, offering services related to agriculture, being engaged as an agent of, or holding out to be, an agricultural professional.
- Adopting, using, or exhibiting the titles or designations prescribed in the constitution of the Institute.
- Doing anything likely to lead persons to infer that the person is a registered agricultural professional.

It is equally an offence for a person, organization, or institution to offer

employment to an agricultural professional who is not duly registered under the Act. A person who contravenes the foregoing i.e., holding out and employing a nonregistered agricultural professional, commits an offence and is liable, upon conviction, to a fine not exceeding ZMW 300,000 (approximately **USD 15,384.62**) or to imprisonment for a period not exceeding ten years, or to both.

Once issued, a practicing certificate should be renewed annually, failing which the certificate becomes void.

Equally worth noting is that once issued, a practicing certificate cannot be transferred to a third party.

#### Conclusion

The operationalization of the Act introduces registration requirements intended to bring about better regulation of the conduct of agricultural professionals in the interest of the agricultural sector.
